### [Introduction]

This template is temporarily prepared for a proceeding for the annual meeting of the Japanese Society for Dental Materials and Devices in English. Your abstract will be offset printed as the proceeding for the meeting. Please follow the instructions of this document. For reader's convenience, please underline the aim of your study and findings.

### [Materials and Methods]

Please send your proceeding as a Microsoft Word file (Word.docx 2010, 2013 format). Please indent the first sentence of each chapter and paragraph. The authors name will be listed your first name and family name as the example of this layout. Your affiliation name is listed only the name of your university or institute. The author, who will present this proceeding, will be added an “\*” mark. This “\*” mark will be converted a circle.

Please write your proceeding within one A4 page. Please try to make your proceeding without a lot of white spaces. Please write your title justified center. In the main text, [Introduction], [Materials and Methods], [Results], and [Discussion] should be described. [Results and Discussion] or [References] are optional.

In [Results] (or [Results and Discussion]), put the conclusion of your study with underlines.

Your proceeding might be subjected for editorial corrections by the editorial committee of *J J Dent Mater* to adjust the format.

### [Results]

Figure, picture and table should be located in single column. The resolution and width of the figures and pictures are expected to be greater than 300 dpi, and 70 –

75 mm, respectively. Insert the figures and pictures in your document file using gray scale with the title of the figures and pictures. Please be careful so that the size of your proceeding doc file is less than 2 MB.

### [Discussion]

For proceeding submission, the Japanese Society for Dental Materials and Devices asks you to complete the registration using OHASYS on-line registration in advance. Please registration your proceeding prepared as a word.docx file to OHASYS

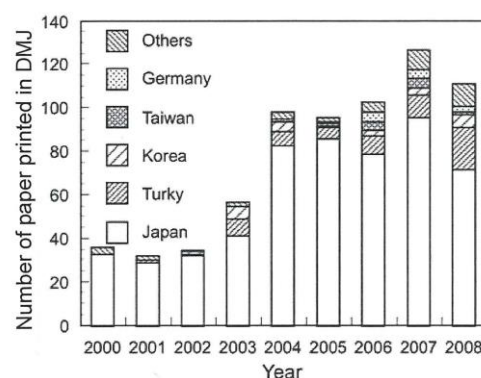


Fig.1 Figure legend
